

City of Temple Sammons Indoor Pool Rental Guidelines

Applicant Granted This Reservation Agrees to Abide by the Following:

1. The facility is available for reservation Friday, Saturday, and Sunday.
2. Rental Price is \$140.00 for 2 hours and \$175.00 for 3 hours with 1-36 guests. **(Non-swimming guests should be included in the total number of people)**. Rental requests must be received no later than 14 days prior to the rental date, unless otherwise approved by the Aquatics Coordinator.
3. The facility is available for use by individuals or organizations of the City for recreation purposes only. Use of the pool for personal gain or for money raising activities is prohibited unless the person or sponsoring organization has pledged the proceeds to charitable or public service programs. All arrangements for preparing and conducting the activities will be the responsibility of the sponsoring organization. The City representative must approve any desired use of the pool other than for recreational purposes. **Groups making reservations are prohibited from raising funds, charging admissions, or tuition, or collecting monies for any reason.**
4. Temple Parks and Recreation Department personnel will be present to open and close the facility, as well as provide lifeguard services. Groups are not permitted to use their own lifeguards.
5. Reservations will be accepted from adults only. Adult chaperones must be furnished with children and youth groups. The minimum requirement is one (1) adult for every ten (10) children.
6. Cancellations made 10 days before rental date will receive a full refund. Cancellations made 5-10 days before rental date will receive a 50% refund. Cancellations made less than 5 days before rental date will not receive a refund. We will allow the renter to switch to another date with no penalty provided that the request is based upon unavoidable circumstances. Decisions will be made at the discretion of the Recreation Superintendent. Any payments made by cash or check will take 2-3 weeks to process. Payments made with credit cards will be processed immediately.
7. All pool regulations, which apply to the general public, must be observed.
8. The individual or organization for whom the reservation is made shall be responsible for any loss or damage to the property during the tenure of their reservation. After use, and before vacating the premises the reserve must clean, remove food and personal items and place all trash in provided containers. The pool and deck area must be left in a clean condition after use.
9. If decorations are planned, permission must be secured from management at the time reservations are made.
10. Excessive loud entertainment will not be permitted.
11. Alcohol is prohibited in the pool, pool area, and park property. Persons who have been drinking intoxicants will be further prohibited.
12. **Lifeguards have final discretion on all pool rules and regulations.**
13. No glass containers of any kind are allowed in the pool area. **No exceptions.**
14. Gambling is not permitted on park property.
15. Smoking, vaping, and the use of other tobacco products are always prohibited in the pool area.
16. The City representative is granted the authority to determine unacceptable behavior of individuals while on the premises, with the right to cancel reservations or request the offender to leave.
17. Permit Holder agrees to comply with all city, state, and federal laws.
18. Patrons must wear a mask inside the facility, unless in the pool.
19. A roster is required by the request of management (Guest List is attached to this form).
20. Temple Parks and Recreation Department reserves the right to cancel or reschedule any reservation due to unforeseen circumstances.

By signing this form, I agree that I have been informed that I should not participate in any activity if I have any doubt or if I am uncertain as to my current medical condition. I hereby certify that I am at least 18 years of age. If I am not at least 18 years of age, the signature of my parent(s) and/or legal guardian(s) must appear below. I have carefully read with a full, definite and clear understanding the foregoing provisions and freely enter into the within agreement of the Waiver and Indemnification Form.
